DETAILS:

On Friday June 20, 2008 at 12:00 pm noon, the Princeton Township Police Department Communications Center received a 9-1-1 call reporting a man entered a residence on Cedar Lane and assaulted an 18 year old female. Patrol Officers and Detectives responded to the area and searched for the suspect who was described as a white male, stocky build, 5' 9", in his 30's, wearing blue jeans and a white t-shirt. The suspect was not located.

The victim told Detectives that the suspect knocked on the door and asked if the homeowner was home. When she said no, the suspected entered the house and sexually assaulted the victim by putting his hand in her pants. The victim struggled with the suspect. The suspect then punched the victim in the face and ran out the front door. The victim was transported by Princeton First Aid and Rescue Squad to the University Medical Center at Princeton where she was treated for her injury and released.

Det. Benjamin Gering and Mercer County Prosecutor's Office Det. Eric Hastings are conducting the investigation.

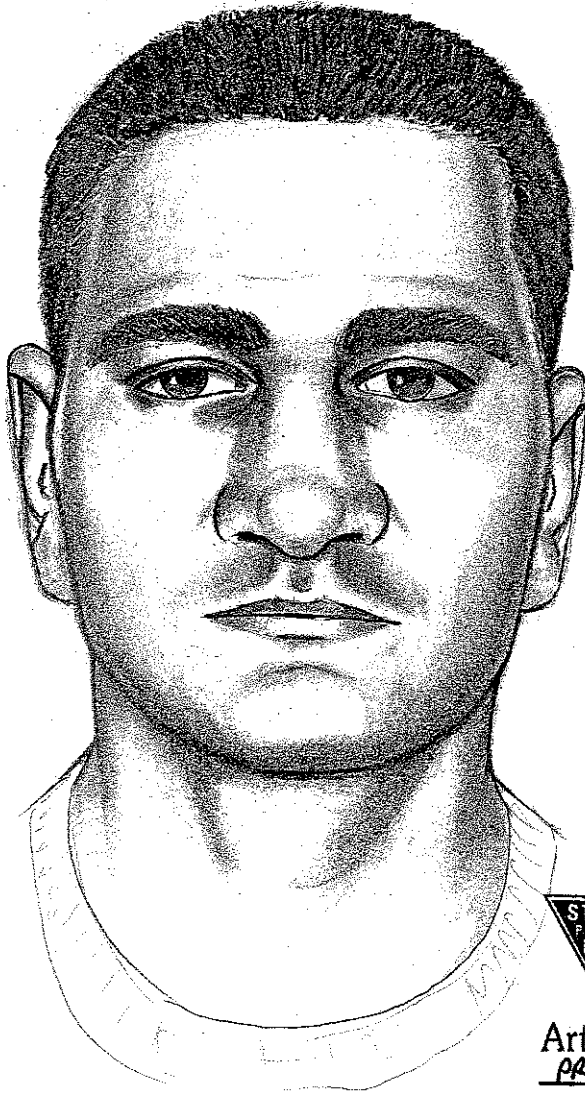
